Subject: Reclassification of SMK Wellness Private Limited from Promoter Group of the Company to Public

We, SMK Wellness Private Limited (formerly known as SMK Wellness LLP) ("SMK") were included in the list of Promoters of SRF Limited by virtue of contribution to 50% of Partner's capital in SMK Wellness LLP by Rose Farms (Delhi) LLP which is one of the promoter group entities of SRF Limited. The aforesaid contribution to 50% of Partner's capital was made on 19-12-2024. Thereafter after conversion of SMK Wellness LLP into a private limited company, 50% of the paid-up capital was allotted to said Rose Farms (Delhi) LLP in SMK Wellness Private Limited.

The said Rose Farms (Delhi) LLP has since sold its entire stake in SMK Wellness Private Limited on 21-03-2025 and thereby does not hold any equity stake or any investment in SMK Wellness Private Limited after that date.

SMK has not been associated to the business or management of SRF Limited or any of the entities in the promoter group of SRF Limited. SMK do not have any right either to appoint any Director of SRF Limited or any ability to control the management or policy decisions of SRF Limited in any manner whatsoever including by virtue of control, if any, exercised by Rose Farms (Delhi) LLP. Accordingly, we request you to declassify "SMK" from Promoter Group of SRF Limited with immediate effect.

We also confirm that SMK or any of its founders/promoters/shareholders:

- (a) do not hold more than 10% of the paid-up equity share capital of SRF Limited;
- (b) do not exercise control over the affairs of SRF Limited;
- (c) do not have any special rights in SRF Limited through formal or informal arrangements including through any shareholder agreement;
- (d) do not hold any position of Board of Directors in SRF Limited;
- (e) do not hold any key managerial personnel position in SRF Limited;
- (f) have not been declared as willful defaulter as per Reserve Bank of India guidelines;
- (g) are not subject to any regulatory action; and
- (h) are not a fugitive economic offender.

2. There is no pending regulatory action against SMK.

Whenever applicable we shall continue to comply with conditions mentioned at sub-clauses (i), (ii) and (iii) of clause (b) of sub-regulation 31A(3) of SEBI (Listing Obligations and Disclosure requirements), Regulations, 2015 as specified above at all times from the date of such re-classification failing which, we shall be reclassified as promoter/ persons belonging to promoter group of the Company.

4. Whenever applicable we shall comply with conditions mentioned at sub-clauses (iv) and (v) of clause (b) of subregulation 31A(3) for a period of not less than three years from the date of such re-classification failing which, we shall automatically be reclassified as promoter/ persons belonging to promoter group of the Company

Rose Farms (Delhi) LLP shall be authorised to issue such undertakings, statements, etc. on behalf of SMK Wellness Private Limited as may be required to declassify SMK Wellness Private Limited from the Promoter Group.
